## INVITATION

### REQUEST FOR EXPRESSIONS OF INTEREST TO LEASE STATE LAND

**IN LINE WITH THE STATE LAND LEASE AND DISPOSAL POLICY, THE DEPARTMENT OF AGRICULTURE, RURAL DEVELOPMENT AND LAND REFORM INVITES POTENTIAL LESSEES TO APPLY TO LEASE THE FOLLOWING FARM SITUATED IN MATLOSANA LOCAL MUNICIPALITY**

#### 1. REMAINING EXTENT OF PORTION 7 OF FARM SYFERFONTEIN 13 HP MEASURING 305,2 280 HECTARES FOR 30 YEARS.

The farm is ideal for livestock farmers with demonstrable records of achievement and success. Records will be a key consideration in the initial selection and shortlisting of potential lessees.

##### 1.1 QUALIFYING CRITERIA:

To qualify, the applicant must meet the following requirements:

1. The applicant must be an African, Indian or Coloured South African citizen.
2. The applicant must be 18 years or older.
3. Have experience in livestock farming or related business management experience and relevant capital/financial requirements.
4. Spouses of public servants shall qualify.
5. Preference will be given to smallholders who are youth, women and people with disabilities.
6. Must have a Brand Mark Certificate.

##### 1.2 SELECTION AND APPROVAL PROCESS:

1. Shortlisting and interview of the shortlisted candidates will be done by the District Beneficiary Selection Committee (DBSC).
2. Final approval for allocation rests with the National Land Acquisition and Allocation Control Committee (NLAACC).

##### Please Note:

1. Applicants who have previously applied to lease land in the Dr Kenneth Kaunda District from the Department of Agriculture, Land Reform and Rural Development and has still not been considered, but meet the criteria mentioned above, are also encouraged to apply.
2. Public servants do not qualify to lease state-owned land.
3. Spouses of public servants shall qualify.
4. Only shortlisted candidates will be formally invited to participate in the selection process outlined above as soon as the initial screening process has been completed.
5. Applicants who do not hear from the department within 30 days of the closing date for applications, must assume that their application was unsuccessful.
6. Applicants are not allowed to visit these farms until they have been advised by the department.
