Farm location: The subject property is situated approximately 50 km west of Thabazimbi and falls under the jurisdiction of the Thabazimbi Local Municipality. Comprehensive directions will be provided to shortlisted applicants.

Applications will be appraised by the Waterberg District Beneficiary Selection Committee (DBSC). The beneficiary selection will be done through a process of shortlisting and interviews. Only shortlisted applicants will be interviewed.

There will be a site briefing on the property for shortlisted applicants **only** before the date of the interviews. Note that this is a privately-owned property which the department is still in the process of acquiring. Applicants and members of the public are **not** allowed to visit this property.
