#### SCHEDULE

# Definitions

 In this Schedule "the Regulations" means the Regulations published by Government Notice No. R. 1683 of 21 November 2003, R. 1684 of 21 November 2003, as corrected by Government Notice No. R. 114 of 6 February 2004 and amended by Government Notice No. R. 934 of 30 September 2005, R. 209 of 10 March 2006, R. 877 of 8 September 2006 and R.60 of 2 February 2007.

## Amendment of Regulation 12 of the Regulations

- Regulation 12 of the regulations is hereby amended by the substitution of sub-regulation
   (3) for the following sub-regulation:
  - "(3) In the case of pigs, the identification mark must be applied by means of tattooing in the left or right ear or on the left or right side of the neck or shoulder area".
